Is It an Audio-Only Phone Call or a Virtual Check-In?

For providers billing communication technology-based services (CTBS) with no video capabilities — that is, an audio-only phone call — the coding options are either virtual check-ins or telephone e-visits

CMS Increases COVID-19 Vaccine Admin Fee

The Medicare payment amount for administering the COVID-19 vaccine is increased, effective March 15, 2021. The national average for physicians, hospitals, pharmacies, and other immunizers to administer the COVID-19 vaccine is now approximately \$12 more for the administration of single-dose vaccines and \$35 more for the administration of two-dose vaccines. Actual rates depend on facility type and geographic location. Learn More »


