Attendee Meals

All meals are served in the Exhibit Hall. Your company will be in the limelight sponsoring the meal events. You may distribute marketing materials at each meal you sponsor, and your company name will be featured on a placard, highlighting your sponsorship of the meal.

Conference Program

Placing a display advertisement in the conference program is a valuable way to alert attendees to your company's products and services. The printed area is 5" x 8" for a full-page ad and 5" x 4" for a half-page ad. Each advertisement will be printed in color. To be featured in the program, you must submit your company logo and description — not to exceed 50 words — by June 30, 2022.

Registration Bag Swag Item/Ad Insert

Placing a swag item (e.g., a pen with your logo on it) or marketing asset in each attendee's bag is a sure way for them to remember your company's presence. Limit 1 swag item and 1 insert per vendor.

Sponsor Tote Bag

Your company logo will be prominently displayed on the conference tote bag that will be distributed to both in-person and virtual attendees.

Sponsorship Deadline

All sponsors must submit their logo and 50-word company description by June 30, 2022. If artwork is not received by this deadline, only the company name will be placed on the designated item and signage.

Logo Specifications

All sponsors must submit their logo in vector artwork with fonts converted to outlines. Artwork must be created in Illustrator CS4 (or newer) formats, Corel Draw, or Freehand. Fonts must be converted to outlines and saved as an .eps file.

Payments are due to AAPC upon invoice and are considered late after (30) days. Cancellations received prior to July 1, 2022, will forfeit nonrefundable deposit. No refunds will be issued after July 1, 2022.

In the event that AAPC is forced to move this event to a fully virtual platform, or through any means other than in-person exhibiting, based on circumstances beyond its reasonable control, such as acts of God, disease, epidemic, pandemic, government-imposed orders, limitations, or restrictions, travel restrictions, war, acts of domestic terrorism, strikes or similar circumstances, make it illegal or impossible to host the conference live, the terms of this Agreement shall be supplemented by the terms in this paragraph: AAPC agrees to provide a reliable technology platform suitable for both attendees and exhibitor use, and to ensure there are no damages resulting from use of the platform. AAPC shall be responsible for training exhibitor on the use of the virtual platform to enhance attendee engagement virtually. Either party may be excused from performance without liability if the Event is believed to likely impair performance under this Agreement, the impacted party will promptly notify the other party in writing. The parties will negotiate in good faith to amend this Agreement but if the parties are unable to reach a mutually agreeable resolution, the impacted party may terminate this Agreement upon written notice.
